The Town of Cobourg By-law #021-2014 states that:

- No person shall own, possess, harbour or keep any dog within the Municipality unless a tag has been issued for the dog by the Municipality in accordance with the provisions of this By-law.
- No person shall keep or permit to be kept:
  - More than **three dogs (3)** within or about any single detached dwelling; or
  - More than **two dogs (2)** within or about any dwelling unit for properties with (2) or more dwelling units.
- The **set fine** for an unlicensed dog is **\$75.00**. The **set fine** for failure to affix a dog tag is **\$75.00**
